IPERS' investment program earned 5.41% return in FY2023

IPERS' investment program earned a 5.41% return in FY2023, slightly exceeding its policy benchmark of 5.27%. At the conclusion of FY2023, the value of the IPERS Trust Fund equaled \$41.13 billion, a \$1 billion increase from the same time in FY2022.

"IPERS overcame several market challenges in FY2023, including interest rate hikes, debt ceiling concerns and uncertainty in some aspects of the private markets sector to achieve a positive return," said IPERS CEO Greg Samorajski. "I'm proud of our team of investment professionals who remain steadfast in their commitment to the long-term security of the IPERS Trust Fund."
