Each spring, IPERS provides an annual benefit statement for current and former IPERS members. Beginning in 2021, IPERS members who have logged in to My Account will receive the annual benefit statement online rather than by mail.

Digital delivery is good for you and IPERS because:



Electronic delivery costs less which means more money stays in the trust fund that pays benefits.



My Account includes more information and options than the paper statements.



My Account provides 24/7 access to your benefits so you don't have to wait for a paper statement each year. The statement is uploaded to My Account several days before it will reach you by mail.

GET STARTED

To access My Account, go to www.ipers.org, and click on My Account Login.

You will need:

- ✓ **Your username**
- ✓ **Your temporary password**

If you are receiving this brochure by mail, your username is shown above. For security purposes, you will receive your password soon in a separate mailing. The temporary password will expire in 15 days.

Anyone else should call IPERS to receive your username and password.

MY ACCOUNT FOR CURRENT AND FORMER IPERS MEMBERS

Current and former IPERS members can utilize My Account at any point during and after your career in public service.

- Assign or change your beneficiary.
- View a history of all your contributions to IPERS.
- View a printable copy of your annual benefit statement.
- View a record of the letters and documents you've received from IPERS.
- Access several downloadable IPERS forms.
- Schedule an appointment with an IPERS retirement counselor.
- Enter various scenarios to generate a real-time benefit payment, service purchase or refund estimate.
- Update your contact information.

MY ACCOUNT FOR RETIREES

Even after you retire, My Account includes important information about your IPERS membership.

- View your benefit payment and contribution history.
- View and change your tax withholdings.
- View income verification information.
- View and change direct deposit information.
- Assign or change your beneficiary.
- View a record of the letters and documents you've received from IPERS.
- Update your contact information.
