



## **Election for Termination of IPERS** Coverage

IPERS received several questions in response to the Employer Bulletin of February 9, 2023. (Part-Time Appointed Officials of Counties and Cities) IPERS has created resources to answer your questions.

The table below will help you determine IPERS' coverage rules for elected and appointed employees. A printable version of this table is available on the new Appointed vs Elected <u>webpage</u>. This page also provides an FAQ section for additional clarification.

IPERS will honor any elections for appointed members made prior to January 1, 2023. Use Occupation Class Code 01 to report appointed members; these members may not opt out of IPERS. You should deduct Social Security, Medicare and IPERS contributions for these members, as well.

Additionally, the Election for Termination of IPERS' Coverage form is updated to reflect these changes. Appointed members are not allowed to opt out of IPERS; their coverage is

IPERS has not changed any coverage rules for elected members. Continue to report these members using Occupation Class Code 17. Deduct IPERS and Medicare if they have chosen to participate in IPERS. Deduct Social Security and Medicare if they have opted out of IPERS coverage. These employees cannot have both IPERS and Social Security deducted from their pay.
